1 ORGANISING AUTHORITY

The Organising Authority (OA) will be the Darwin Sailing Club

2 VENUE

The venue will be Darwin Sailing Club, Fannie Bay, NT, Australia.

3 EVENT GRADING

The event has been granted World Sailing Grade 3 status for the regatta. This grading is subject to review by World Sailing. The event may be re-graded when there is clear reason to do so.

4 PROVISIONAL PROGRAMME

4.1 The regatta will be held between Tuesday 2nd and Saturday 6th July 2019

4.2 Unless excused by the OA, attendance at the following is mandatory:

- (a) Teams Briefing, Press Conference & Welcome Function – teams.
- (b) Daily briefing, for skippers.
- (c) Press Conferences, for skippers.
- (d) Awards Ceremony - teams

5 SKIPPERS ELIGIBILITY

- 5.1 Not more than eight skippers will be invited. Only skippers invited by the OA will be eligible to enter this event.
- 5.2 Skippers wishing to enter should register their interest with the OA by completing the online “Application for Entry” by 1700 hrs on Friday 19th April 2019. Late ‘Applications for Entry’ may be accepted at the discretion of the OA and subject to the numbers and rankings of skippers applications received by the close date.
- 5.3 First round invitations will be issued by 30th April, 2019.
- 5.4 To remain eligible a skipper shall confirm acceptance of the invitation in writing, [fax or e-mail is acceptable] to be received by the date specified on the ‘Invitation to Enter’.
- 5.5 A non-refundable entry bond of \$AUS 500 shall accompany the acceptance of the invitation for this to be valid. This may be deducted from the full entry fee.
- 5.6 All competitors shall meet the eligibility requirements of World Sailing regulation 19.2.
- 5.7 All competitors shall be under 23 years of age on the 1st July 2019.
- 5.8 All competitors shall obtain a World Sailing Sailor ID by registering online at www.sailing.org/isafsailor. Skippers shall inform the OA of their World Sailing Sailor ID at registration.
- 5.9 The registered skipper shall helm the boat at all times while racing, except in an emergency.

6 ENTRIES

6.1 Entering

Invited teams may enter by completing the ‘Confirmation of Entry’ form included in the ‘Invitation to Enter’ documents. The skipper shall be entered on completion of registration, crew weighing

and the payment of all fees and deposits. All payments shall be made by credit card, bank deposit, cash or cheque.

6.2 Entry Fee

A non-refundable entry fee of AU\$1,200 shall be paid by 1700 hrs on Friday 21st June 2019.

6.3 Withdrawal

When a skipper accepts an invitation and later withdraws within two months of the event or leaves the event before the end without written approval from the OA, a zero score may be applied to their Ranking points for that event by the ISAF. (WS Regulation 27.2)

6.4 Damage deposit

- (a) An initial damage deposit, or credit card authority of AU\$ 1,000 shall be paid on, or before registration, unless extended by the OA. This deposit is the maximum payable by the skipper as a result of any one incident.
- (b) If a deduction from the damage deposit is decided by the OA, it may require that the deposit be restored to its original amount before the skipper will be permitted to continue in the event.
- (c) In the event that the OA insurance refuses to pay for damage the skipper(s) shall be liable for all damage incurred
- (c) Any remaining deposit after the event will be refunded within 10 business days of the conclusion of the event.

7 RULES

- 7.1 (a) The event will be governed by the rules as defined in the RRS 2017-2020, including Appendix C.
- (b) The rules for the handling of boats will apply, and will also apply to any practice sailing and sponsor races. Class rules will not apply.
- (c) Any prescriptions of the national authority that will apply will be posted on the official notice board.
- (d) The official event notice board will be at the regatta office.

8 BOATS AND SAILS

- 8.1 The event will be sailed Elliott 7 type boats.
- 8.2 Four boats will be provided.
- 8.3 The following sails will be provided for each boat: Mainsail, Jib and Asymmetrical Spinnaker
- 8.4 Boats will be allocated by draw, either daily or for each round, as decided by the race committee.

9 CREW (INCLUDING SKIPPER)

- 9.1 The number of crew (including the skipper) shall be four or five. All registered crew shall sail all races.
- 9.2 **Crew Weighing**
- (a) The total weight of the crew, including the skipper, dressed in at least shorts and shirts, shall not exceed 350 kg, determined at the time of registration or such time as required by the RC.
- 9.3 When a registered skipper is unable to continue in the event the OA may authorise an original crew member to substitute.
- 9.4 When a registered crew member is unable to continue in the event the OA may authorise a substitute, a temporary substitute or other adjustment.
- 9.5 All competitors while aboard the Elliot 7's shall wear a Personal Flootation Device ("PFD") at all times during the series. Competitors are to provide their own compliant PFD. Each PFD shall meet and be branded in accordance with AS 4758 (minimum Level 100) or AS 1512-1996 Type 1 or equivalent (or more stringent) overseas standard. In the event that a competitor is unable to provide a compliant PFD the OA may provide one.

10 EVENT FORMAT

- 10.1 Skippers will be seeded into a round robin based on the World Sailing ranking list 30 days prior to the event.
- 10.2 The event will consist of the following stages:
- Stage 1 - Two rounds robin.
 - Stage 2 - Quarter finals – first to score two points
 - Stage 3 - Semi Finals - first to score two points
 - Stage 4 – Petit Finals – first to score two points
 - Final – first to score three points
- 10.3 The RC may change the format, terminate any stage or the event when, in its opinion, it is impractical to attempt to hold the remainder of matches under the existing conditions or in the remaining time scheduled. Early stages may be terminated in favour of later stages.

11 COURSE

- 11.1 The course will be windward/leeward with optional offset legs in the event of significant cross course current, resulting in either port or starboard roundings and finishing downwind.
- 11.2 The intended course area will be set on the waters of Fannie Bay, NT and is shown on Australian Chart AUS 26.

12 ADVERTISING

- 12.1 As boats and equipment will be supplied by the Organising Authority, ISAF regulation 20.4 applies. Each boat will be required to display advertising as supplied by the OA.
- 12.2 Competitors may be permitted to display advertising ashore at the venue, but this is subject to individual negotiation with the OA.
- 12.3 Boats shall not be permitted the right to protest for breaches of any rules regarding advertising (amends RRS 60.1).

13 PRIZES

- 13.1 The principal award for first place will be the Australian Maid Perpetual Trophy.
- 13.2 The OA may withhold awards, in the case of misconduct or refusal to comply with any reasonable request including attendance at official functions.

14 MEDIA, IMAGES and SOUND

- 14.1 If required by the OA, cameras and equipment supplied by the OA shall be carried on board while racing.
- 14.2 Competitors shall not interfere with the normal working of the OA supplied media equipment.
- 14.3 The OA have the right to use any images and sound recorded during the event free of any charge.

15 COACH BOATS

- 15.1 The OA will provide boats from which coaches may observe racing and communicate with their teams between matches. Individual coach boats will not be permitted.
- 15.2 The OA will not provide berths for coach boats.
- 15.3 Any interference by a coach boat with the racing or event organisation may result in a penalty applied at the discretion of the Protest Committee to the associated skipper or team under the provisions of RRS 64.4.

16 OTHER REQUIREMENTS

- 16.1 Each team is requested to provide a burgee of the club they represent approximately 90cm long for display ashore.

17 DISCLAIMER

All those taking any part in the event do so at their own risk. The OA, its associates and appointees accept no responsibility for any loss, damage, injury or inconvenience incurred, howsoever caused.

18 INVITATIONS
